Summary On Saturday, 07-13-2013, at approximately 1925 hours, Party #1 (Cubano) was driving Vehicle #1 (VW) westbound on Pine Canyon Road east of Three Points Road at an unknown speed within the westbound lane. Party #1 was driving Vehicle #1 while under the influence of an alcoholic beverage and at an unsafe speed for the prevailing roadway and crossed into the eastbound lane of traffic and onto the dirt shoulder south of the eastbound lane of traffic and collided into a dirt embankment. Vehicle #1 continued westbound on the dirt shoulder that or the driver side of Vehicle #1 collided into a tree. That collision caused Vehicle #1 to continue westbound and overturn. Vehicle #1 came to rest on its driver side. As a result of this collision Party #1 sustained fatal injuries. CHP, LASD, and LA County Fire Department personnel responded to the scene and provided assistance. This news release is preliminary as this investigation is continuing. Alcohol appears to be a factor in this collision and will be investigated further. On 07-14-2013, at approximately 0005 hours, next of kin notification was made.
