SUMMARY

On March 9, 2016, at approximately 10:42 A.M., a witness observed a vehicle several hundred feet off the roadway, in the desert. The vehicle had traveled from Avenue N-8, in a northeasterly direction into the desert and became stuck on a large sage brush. For unknown reasons the vehicle became engulfed in flames. The driver, Party # 1, a resident of Palmdale, CA, was unable to exit the vehicle and was later determined to be deceased.

ADDITIONAL INFORMATION:

Avenue N-8 was closed from 36th Street West to 38th Street West for approximately 2 hours, but there was no effect on traffic.

Alcohol (and/or) drugs is not suspected to be a factor in this collision.
